RELEASE AND WAIVER LIABILITY

THIS RELEASE AND WAIVER OF LIABILITY ("Agreement") is entered into this 8th day of September, 2018, by and between _____ ("Participant"), Equestrian Zone Poker Ride & Run ("Event"), Jacki Miller/Jodi Kusturin ("Directors"), and Equestrian Zone ("The Non-Profit").

In consideration of being permitted to compete, officiate, observe, work for, or for any purpose to participate in any way in the Event, the Participant, for him/herself, his/her personal representative, heirs and next of kin, acknowledges and agrees as follows:

1. Participant hereby releases, waives, discharges and covenants not to sue Non-Profit, the Event or the Director, their individual members, promoters, participants, affiliated entities and associations, sanctioning organizations or any subdivision thereof, operators, owners, supervisors, employees, crews or any persons in any recreational area, sponsors, advertisers, owners and lessees of premises used to conduct the Event and each of them, their officers and employees, all for the purposes herein referred to as "Releases", from all liability to the Participant, his/her personal representatives, heirs, assigns, and next of kin or any and all loss or damage, and any claim or demand therefore on account of injury to the person or property or resulting in death of the Participant, whether caused by the negligence of the Releasees or otherwise while the Participant is in or upon any recreational area and/or, competing, officiating, observing, working for or for any purpose participating in the Event.
2. Participant hereby agrees to indemnify and save hold harmless the Releasees and each of them from any loss, liability, damage or cost they may incur due to the presence of the Participant in or upon any recreational area or in any way competing, officiating, observing or working for or for any purpose participating in the Event whether caused by the negligence of the Releasees or otherwise.
3. Participant hereby assumes full responsibility for and risk of bodily injury, death or property damage due to the negligence of Releasees or otherwise while in or upon any recreational area and/or while competing, officiating, observing or working for or for any purpose participating in the Event.
4. Participant hereby recognizes that there is a significant element of risk including, but not limited to, serious injury and/or death and/or property damage involved in the Event. Knowing the inherent risks, dangers, and rigors involved, the Participant certifies that he/she is in good physical condition and possesses sufficient skill and experience to safely participate in the Event. The Participant acknowledges the dangerous nature of the activity and the fact that not all of the stresses and hazards connected with the Event can be foreseen or prevented even though reasonable precaution are taken. The Participant understands that he/she is personally responsible to follow the established safety rules and the rules and regulations of the state of Arkansas and is to wear proper attire.
5. The Participant further expressly agrees that the foregoing Release and Waiver of Liability is intended to be as broad and inclusive as is permitted by the law in the State of Arkansas and that if any portion of this Agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
6. The Participant has READ AND VOLUNTARILY SIGNS the Release and Waiver of Liability, and further agrees that no oral representatives, statements or inducements apart from the foregoing written Agreement have been made.
7. Participant further recognizes that Releasees are under no duty to monitor Participant throughout the entirety of the Event, and will not be monitoring the completion of the Event for every participant.
8. Participant further acknowledges that failure to maintain minimum speed in the Event will negate all liability on the part of the Releasees.
